Sub: - Grant of Notional Annual Increment to Employees Retiring on 30th June -Regarding.

The State Government had decided a uniform date of annual increments for all State Government employees under Rajasthan Civil services (Revised Pay) Rules, 2008 and onward. The employees who had completed incremental period of service under these rules and retired on 30th June were not eligible for the increment of 1st July, since they were not in service.

The Government has considered the matter in the light of various decisions of the Hon'ble Courts in this regard and decided to grant annual increment to the Government servants who retire on 30th June, 2006, and following 30th June, thereafter whose increment becomes due on the next day following upon their retirement, and upon completing one year of satisfactory service, shall be granted a notional increment on 1st July.

This increment shall be considered as an emolument for pension purposes only and shall not be considered for gratuity, commutation, and encashment of unutilized privilege leave.

The benefit of this increment shall be notional from 1st July, 2006, to 10th April, 2023, and cash benefits shall be allowed from 11th April, 2023 (the date of the Hon'ble Apex Court decision) onward.
