Sub: Shifting of administrative structure and functions of Rajasthan Government Health Scheme.

Ref: FD order No. F.6(1)FD/Rules/2021 dated 30.11.2023


Vide FD Order dated 30.11.2023 considering the nature of RGHS and Mukhyamantri Chiranjivi Swasthya Bima Yojana (presently Mukhyamantri Ayushman Arogya Yojana) was same, decision was taken that Project Director, RGHS and all the team of RGHS shall work under Rajasthan Health Assurance Agency (RSHAA) and the powers presently used by Director, SIPF shall be used by CEO, RSHAA.

In continuation, now State Government has taken decision for shifting of administrative structure and functions of RGHS as a separate vertical under Rajasthan State Health Assurance Agency / Medical and Health Department to ensure systemic integration with systems of Mukhyamantri Ayushman Arogya Yojana.

For this purpose the office of Rajasthan Government Health Scheme alongwith staff which is under administrative control of CEO, RSHAA would also be under the Medical and Health Department.

This bears approval of Honble Deputy CM (FM) vide ID No. 581/Dy.CM(D)/2025 dated 23.05.2025.
